SUMMER 2013 REGISTRATION – ADDS & DROPS (CAMPUS CLASSES)

The deadline to add a campus class for credit for the summer semester is **May 6**. Any requests for adds beyond that date will require an [Academic Petition](#). Audit/non-credit registrations can be made up to one week prior to the start of a particular class. If a student needs to drop a class, the deadline to receive 100% refund is May 13, 80% refund is May 27, and 50% refund is June 10. The drop deadline in [SIS](#) for all courses being taken for credit is **June 10**. Any drops beyond that date will require an Academic Petition. On **May 29**, the Legal and Ethical Issues class for the Marital and Family Therapy program is having a guest speaker, [Kevin Snider](#), from 7-9pm. The topic will be “Legislative attacks on religious freedom: Can churches, therapists, and clients maintain freedom of conscience?” All Western students, alumni, staff and faculty are welcome to attend free of charge. Kevin Snider has been an attorney since 1994 and the Chief Counsel of Pacific Justice Institute (PJI) since 2004. At PJI he gives legal counsel to pastors and religious leaders on a day in and day out basis on a variety of church issues. He has taught church law to seminary students and is a frequent presenter at seminars on church law and religious liberties. Recently he has served on the Commission On Accountability & Policy For Religious Organizations (Legal Experts Panel) for the Evangelical Council for Financial Accountability.
